### Please Carefully Read. This Effects Your Legal Rights

I/We have read all rules before signing this waiver.

This property is privately owned. The camper accepts camping privileges with the understanding that he or she does hereby release Eagle Ridge Festival and Campgrounds, LLC, its officers, families, volunteers and employees, of all liability for the loss or damages to property and injury to his/her person arising out of his/her use of its camping facilities and agrees to indemnify the grounds, its officers, families, volunteers and employees, against claims resulting from loss or damage to property or injury to the person(s) or visitor(s) of any member of the family of the camper, arising out of the use of its facilities and any activities, games or events sponsored by Eagle Ridge Festival and Campgrounds, LLC.

I/We agree to pay for any damages to property, sites, building, facilities, equipment or loss of equipment, which may occur. I/We also agree to immediately report any accident, injury or property damage to the manager or staff. If a hazard or dangerous situation exists on the premise, the said camper will notify the management or staff immediately.

I/We also agree to take full responsibility for ourselves and all people in our party, including minors and visitors, and will require them to read and comply with all property rules and regulations as posted in the office or on the grounds, as well as the terms and conditions as set forth in this registration form.
